Narrative:

Lancaster Station's Robbery Suppression Team reports the following recent noteworthy criminal convictions.

On February 19th, 2013, Corey Santifer (22) pled guilty to three counts of robbery and was sentenced to 18 years in prison. Santifer committed three robberies between September 21st and September 26th 2012 of local businesses- Baskin Robbins, Wienerschnitzel and Deltaco.

During each robbery, Santifer stated he had a gun and demanded money. Robbery detectives located Santifer in a vacant house one day after the last robbery.

On March 4th, 2013, a jury convicted Daveion Overman (21) and Ronyen Carter (21) of robbery, theft and false imprisonment. On July 22nd, 2013, Overman and Carter were involved a home invasion robbery in the city of Lancaster. During this robbery a victim was tied up and their property was taken. Robbery detectives arrested Carter and Overman approximately one month after the robbery during their investigation. The District Attorney's Office diligently prosecuted the case. The defendants are awaiting sentencing.

On March 5th, 2013, Dillon McCloud (21) pled guilty to carjacking and other charges and was sentenced to seven years in state prison. On February 11th, 2013, McCloud carjacked a vehicle parked at the AM/PM on 60th St West, Quartz Hill. The victims were forced out of their vehicle by McCloud holding a knife. McCloud fled from deputies in the stolen vehicle and a vehicle pursuit ensued. McCloud was arrested after deputies deployed spike strips in Santa Clarita.
